III. Action items

- 1. Minutes from the February 7, 2013 meeting were approved as sent out.
- 2. A motion was made by Cindy Peterson to approve a proposal from the Department of Teacher Education to require ENGL 1703 Composition II: Writing and Research for all Teacher Education majors. The motion was supported by Dave Wegley. The committee voted unanimously to adopt the motion.
- 3. Dave Wegley moved the adoption of SPMT 1202: Sports Dynamics & Performance as a class meeting the General Education Self-Understanding outcome. Jack Jones discussed the revised/updated rubric.

Further discussion ensued about whether the proposed class met the General Education Self-Understanding outcome and whether the School of Business was the appropriate academic school to offer such a class.

Upon recommendation by Jamie Myrtle, Cindy Peterson moved to table the motion to approve SPMT 1202: Sports Dynamics & Performance as a class meeting the General Education Self-Understanding outcome until further clarification and guidance is obtained regarding which governance body on campus has the authority to decide academic territory issues. The motion was supported by Earl Bland. The committee voted unanimously to table the proposal. For the same reason, the committee also deferred any decision regarding SPMT 2301, 2401, 3301, 3401, and 3202.

4. A motion was made by Earl Bland to refer to the Academic Affairs Committee and/or Faculty Assembly the policy issues of a)Which governance body on campus has the authority to decide academic territory issues? and b)Who owns the general education core?

The motion was supported by Jonathan Downs. The motion was unanimously approved.
